Explore and set up crowdfunding platforms and apply grants while building a community around your idea. Tailor proposals to highlight your environmental and community impact. Share your mission clearly to gain supporters and attract resources.

Research competitive pricing strategies that reflect your value while staying accessible. Factor in costs and long-term sustainability goals.

Google Sheets: Create a dynamic pricing model to track costs, margins, and market pricing. Use formulas to calculate your break-even point and profit margins, adjusting as needed to stay competitive and sustainable.

Float: Use Float to forecast cash flow and manage budgets, ensuring your pricing strategy aligns with your financial goals and long-term sustainability.

QuickBooks: Keep track of expenses, income, and taxes to help adjust your pricing strategy in real-time based on actual performance and ensure it supports business growth. quickbooks.intuit.com

Xero: Use Xero's real-time accounting tools to monitor financial health, helping you adjust prices for products or services based on up-to-date profit and loss data. https://www.xero.com/ie/
